- DESIGN REVIEW APPLICATION FORM**
- SITE PLAN** must show existing and proposed site topography as well as site boundaries and any and all proposed site improvements, including drainage system
- ROOF PLAN AND FLOOR PLANS** must show roof and floor plans for each floor of each structure
- EXTERIOR ELEVATIONS** must show each exposed side of each proposed structure (including typical walls and fencing).
- COLOR/MATERIAL BOARD** must include roof sample and paint chips.
- PRELIMINARY LANDSCAPE PLAN** must show the plant materials, planting details indicating height of mature trees, garden walls, fences, irrigation, drainage, and any appurtenant exterior structures. If landscape plan is not submitted at time of final design approval, owner must submit the plan prior to commencing work.
